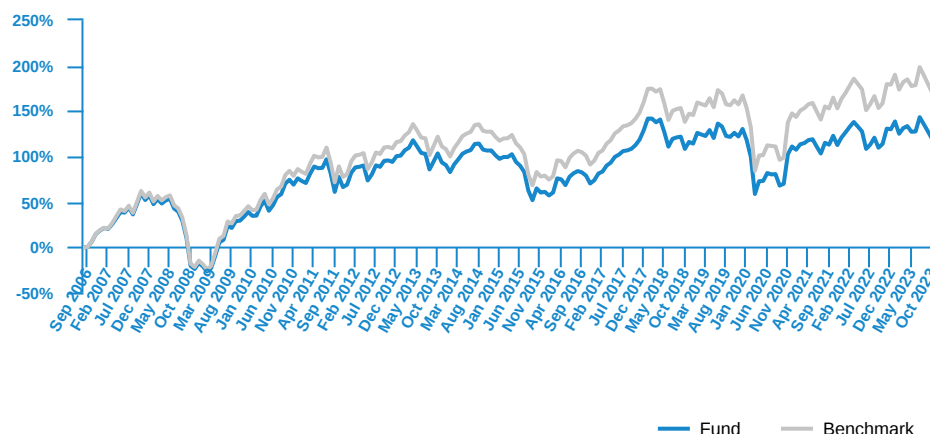
Fund Objective

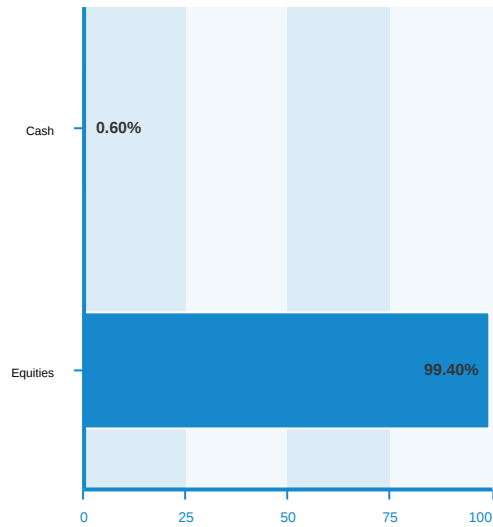

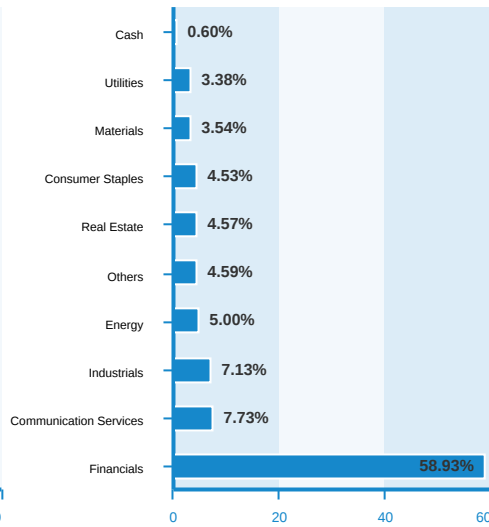

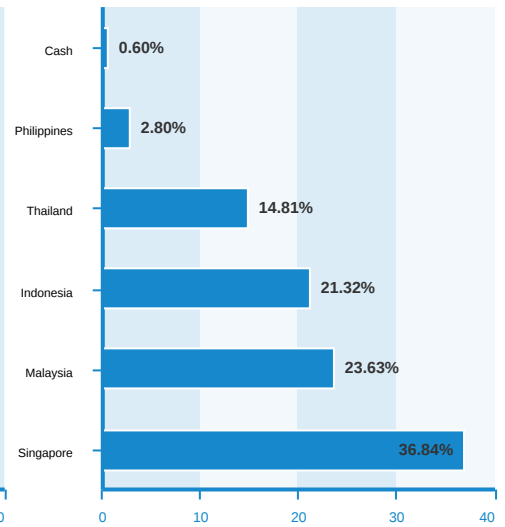
Asset Allocation (%)
